PROFESSIONAL EXPERIENCE

During the past thirty years worked in the field of Epidemiology and Public Health, particularly in the design, conduct, analysis and interpretation of studies and cross checks, as well as the development of health programs, namely in screening. Most of the work was developed in research on chronic diseases mainly in oncology and in Health Planning indicators.

Since 1988, has been responsible for implementation and coordination of the South Regional Cancer Registry, which is a population based one of about 4 800 000 inhabitants, having produced numerous information as regards health indicators and more then ten publications about incidence and survival in South Portuguese Region.

Since 1993, is Epidemiology consultant of the Center for Pharmacoepidemiology Studies of the National Pharmacy Association, and provide collaboration in the development of some projects of drug's use, namely therapeutic profile, profile of prescription and self medication.

As part of Community Networks, participates as a representative of the ROR-SUL, in the "European Network of Cancer Registries and the ACCIS". Was also representative of Portugal in the European project EUROCHIP I (2003). Portugal's representative on the European project EUROCHIP II (2005).

In 2018 was nominated Nacional Coordinator of the Nacional Cancer Registry and in 2016, was involved in the study "SUDCAN - Cancer survival in European Latin countries", with collaboration with GRELL and EUROCARE.
